Approval of Records

Submission of Proposals

Reading Initiative

Mrs. Beyer moved the Superintendent's recommendation to authorize submission of the DOE FY2009 John Silber Early Reading Initiative Proposal for the Huntington School and, if successful, the expenditure of funds. The School Department will apply for the maximum eligible award for Brockton of up to \$100,000.

After a brief discussion on the motion, the vote was taken.

Technology Enhancement Competitive Grant The DOE issued an RFP for its *FY2009 Technology Enhancement grant*. Brockton Schools is partnering with Braintree Public Schools to submit a proposal to support the school districts in providing face-to-face and online professional development aligned with the Department's technology literacy standards and instructional strategies to integrate technology effectively into instruction.

The districts will submit a collaborative proposal to seek \$100,000 in grant funds and will enter into a contact with Bridgewater State College's Division of Graduate Education as a provider to develop and instruct courses. Additionally, the grant funds will be used for stipends for teachers and materials for the professional development.

Mr. Daley moved the Superintendent's recommendation to authorize submission of the abovementioned proposal and, if successful, the expenditure of funds.

Safe & Supportive Learning Environments

Mrs. Beyer moved the Superintendent's recommendation to authorize the submission of the *FY2009 Safe and Supportive Learning Environments Proposal (791-B)* for the Raymond and Huntington schools in the amount of \$24,993 and, if successful, the expenditure of funds.

On the motion, questions were asked regarding the proposal and were answered by Julianne Andrade, Coordinator of Reading, Language Arts and Social Science, K-8.

B. Russell Alternative Schools in the amount of \$74,996 and, if successful, the expenditure of funds.
